The event is an open competition loose surface autocross type event held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland, including Appendices 85.3,86 & 87 of the current Motorsport Ireland yearbook, these supplementary regulations and any final instructions issued before the start of the event. The event is organised and promoted by the Cork Motor Club. Motorsport Ireland .I. Permit No: **22/066** has been issued for the event. The organisers have reserved the right to cancel or postpone the event or part of it in exceptional circumstances.

Entries are open to all drivers whom hold a current competition license and log book which must be produced at scrutiny. Entries are open on publication of these regulations

Competitors will be excluded from the results for the following offences.

- 1 Unofficial Practice in any type of vehicle.
- 2 Failure to wear safety belt and crash helmet of the approved type while on the course.
- 3 Failure to have appropriate type fire extinguisher in the car at all times during the event
- 4 Failure to pass scrutiny or to arrive at scrutiny after practice has begun.
- 5 Failure to obey a reasonable request from an official.

Scrutiny Requirements.

All competing vehicles must carry a Seat Belt Cutter.

All cars must pass scrutiny

All cars must be fitted with fire extinguishers of approved type

All cars must be fitted with full roll cage and have laminated windscreens.

All cars must be fitted with FIA approved seats.

Fire proof clothing must be worn as per MI regulations.

Overhead/ roof skid pans and side netting are compulsory on specials.

Seats, safety belts and helmets of approved type must be used. See specification in current yearbook and latest MI bulletins.

Classes

Class 1: All Saloon cars up to 1450 c.c.

Class 2: All Saloon cars from 1451 c.c.to 1650 c.c. with not more than 2 valves per cylinder

Class 3: All Saloon cars from 1451 c.c.to 1650 c.c. with more than 2 valves per cylinder

Class 4: All Saloon cars from 1651 c.c.to 2100 c.c.

Class 5: All Saloon cars over 2100 c.c., 4WD cars and Turbocharged Saloon Cars.

Class 6: Motorcycle Engined Specials including Buggies over 1300cc. Only open to competitors 18 years and over.

Class 7: Car Engined Specials. Only open to competitors 18 years and over.

Class 8: "Intermediate class" for 16 – 18 year olds, holding a "Speed National B license in saloon cars up to 1650cc.

Class 9: "Junior class" for 14 – 16 year olds, holding a "Junior" license in saloon cars up to 1450cc.

Class 10: Motorcycle Engined Specials including Buggies up to 600cc. Only open to competitors 18 years and over.

Class 11 Motorcycle Engined Specials including Buggies 601cc to 750cc. Only open to competitors 18 Years and over.

Class 12 Motorcycle Engined Specials including Buggies 751cc to 1299cc. Only open to competitors 18 Years and over.

Class 13 J1000 For holders of Junior Rally or Junior Speed licences with cars complying to J1000 Technical Regulations as published on MI website, Co drivers are compulsory and must hold a minimum of National B competition licence and be 21 years old or over.

Awards

FTD Specials/Buggies & FTD Saloons, 1st, 2nd & 3rd in each class, Best C MC Driver, Ladies Award and Best Newcomer.

Winners of the overall award will not be eligible for class awards. Additional awards may be presented.

Protests will only be accepted as per MI regulations. No case for force majeure will be considered once a competitor has started the event.

THE CLERK OF THE COURSE HAS THE RIGHT TO REFUSE AN ENTRY without having to assign a reason.

On Line Entry only with online payment (corkmotorclub.com) with entry fee of €125, J1000 entry fee €75 Inc. Nav, Junior entry fee €75 Entry to be received no later than Wednesday 6th July to be included.

In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified the Cork Motor Club Ltd (Organising Club), Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland, landowners and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents.
